1. INTRODUCTION AND SCOPE

This Policy governs the terms of use for Subscribers of the **Aquireef3D commercial license subscription service**, operated by **Linas Vidmantas**, acting under the brand name **Aquireef3D** (hereinafter referred to as the “Provider”).

The service grants eligible Subscribers a **tier-based, non-exclusive, non-transferable, and revocable commercial-use license** to access digital design files (STL files) created by the Provider, for the sole purpose of **3D printing and selling physical products** derived from those files. This license is valid **only while the subscription remains active and in good standing**.

By subscribing to any commercial tier, and by accessing, downloading, or using any file or resource provided under this service, the Subscriber **acknowledges and agrees** to be fully bound by the terms of this Policy. Any such use constitutes the Subscriber’s **explicit acceptance** of all terms, restrictions, and obligations set forth herein.

2. LICENSE GRANT AND RESTRICTIONS

License Type: Non-exclusive, non-transferable, revocable commercial-use license to sell physical products made from provided STL files.

2.1. Allowed

- **3D Print and Sell Physical Products**
You are granted the right to manufacture and sell **an unlimited number of physical items** that are 3D printed using the STL files provided under your active subscription tier. Sales are permitted globally unless prohibited by local law.
- Sell physical products made from Aquireef3D STL designs **directly to end customers ONLY** through your own disclosed and approved sales channels only.
- **Sell on Multiple Sales Channels** (each sales channel must be disclosed to the Provider as outlined in §3).
You may offer physical products on:
 - Online marketplaces (e.g., Etsy, eBay, Amazon)
 - Your own personal or business websites
 - Social media storefronts (e.g., Facebook Shops, Instagram)
 - Physical retail shops, events, exhibitions or pop-up stores
- **Use Included Commercial Image Packs for Promotion**
You are permitted to use & modify the **provided marketing images** (included with each STL file) for the purpose of promoting the physical products you manufacture. These images may be used on your listings, websites, printed materials, and ads, so long as credit is provided to Aquireef3D where required.
- **Price and Brand Products Freely**
 - You may set your own retail pricing and branding (under your name or business), but you must not claim authorship of the design or remove required attribution to Aquireef3D where applicable.



2.2. Prohibited

- Share, sell, upload, resell, trade, rent or otherwise distribute STL files, images or tools in any digital format—modified or unmodified;
- Resell printed products in bulk to third-party individuals, stores or companies with the intent that they will independently resell those products through separate channels or brands;
- Act as a supplier or wholesaler of Aquireef3D licensed products to other entities;
- Operate or build a resale network, franchise system or distribution network using designs obtained through an Aquireef3D subscription or license, unless formally authorized by Aquireef3D in writing.
- Use any part of the files or tools for creating derivative works intended for resale or redistribution in digital format;
- Claim authorship or design credit for Aquireef3D content or any derivative based on it;
- Upload STL files to online marketplaces, file-sharing platforms, design libraries, or AI-training datasets;
- Gift, donate, loan or otherwise transfer the files, images or business tools to third parties in any form, even without monetary exchange. This includes giveaways, collaborations, portfolio samples or “community sharing” and any other forms of redistribution.
- Reverse engineering or modification.
- Unauthorized redistribution or unauthorized usage of any materials received from the Provider.

Disclosure Required: Every sales channel must be submitted upfront. Failure to do so may result in takedowns. See §3 for more details.

3. SUBSCRIBER RESPONSIBILITIES

- Prior to any commercial activity, the Subscriber must disclose Aquireef3D via email (info@aquireef3d.com) of all intended sales channels, including store names, direct links, marketplace usernames and any other relevant business information. Any changes to sales channels (adding or removing platforms, renaming stores, etc.) must also be reported in advance. Failure to provide this information prior to activity may result in takedown notices, DMCA enforcement or other legal actions without further notice. Aquireef3D assumes no liability for any resulting loss or disruption in these cases.
- Maintain account security.
- Provide truthful business/platform info.
- Notify Provider of changes within 7 days (info@aquireef3d.com).
- Comply with local and international laws.
- Store, market, and sell ethically.
- Always credit Aquireef3D as the designer:
 - “This design is created by Aquireef3D”;
 - Where applicable (online marketplaces, stores etc.) also input link to www.aquireef3d.com
 - This rule has one exemption: if the platform prohibits attribution or design credit, the Subscriber must submit a direct link to that platform’s official policy within

three (3) business days. Provider reserves the right to deny or approve such exceptions in writing.

4. SUBSCRIPTION TERMS

Billing: Monthly via Patreon. Auto-renewal unless cancelled. Patreon rules, as well as other terms and conditions apply. Check them directly on the Patreon platform.

4.1. Tier Breakdown

STARTER Tier (\$10/month):

- **STL Files Included:** 1 STL file per month, selected by Aquireef3D from the previous month's 5 designs of Builder /Pro / Elite tier.
- **Images Included:** 3 commercial-use marketing images per STL.
- **Support:** Basic 3D print guidance via email or discord, response time within 48–72 hours.
- **License Rights:** Valid only during an active subscription. If you cancel or miss payment, the right to sell any product based on that file is immediately revoked. Rights cannot be retroactively reinstated.

BUILDER Tier (\$39/month):

- **STL Files Included:** 5 never-before-released STL files delivered monthly. These will be provided under same conditions for the Builder / Pro / Elite tiers.
- **Images Included:** 5 commercial-use images per design.
- **Support:** Basic 3D print guidance via email or discord, response time within 48–72 hours.
- **License Rights:** Rights to sell physical products made from these files remain valid only while the subscription is active and uninterrupted. Cancellation or payment failure permanently ends resale rights for all files received.

PRO Tier (\$75/month):

- **STL Files Included:**
 - **One-Time Starter Pack:** 20 exclusive STL files, not released publicly. After 6 months, they will be replaced with 20 new designs.
 - **Monthly Files:** 5 fresh STL files per month (never previously released). These will be provided under same conditions for the Builder / Pro / Elite tiers.
- **Images Included:** 10 commercial-use marketing images per design.
- **Support:** Priority print support per email or discord with 24-hour response time.
- **License Rights:** You may sell printed products based on any STL received while your subscription is active. Cancellation or payment failure permanently ends resale rights for all files received. Rights scale monthly as follows in the example:
 - Month 1: 20 starter + 5 monthly = 25 designs
 - Month 2: 25 + 5 = 30 total licensed
 - Month 6: 70 licensed (20 new + 30 monthly + 20 replaced starter files)

- If you cancel or miss payment, all rights terminate immediately.

ELITE Tier (\$95/month):

- **Includes All Pro Benefits**, plus:
 - **Business Calculator:** Exclusive XLSX calculator for pricing, cost estimation and profitability planning.
 - **Consulting:** 20 minutes of 1-on-1 business coaching per month (booked in advance per online calendar).
- **Support:** Priority print support per email or discord with 24-hour response time.
- **License Rights:** You may sell printed products based on any STL received while your subscription is active. Cancellation or payment failure permanently ends resale rights for all files received. Rights scale monthly as follows in the example:
 - Month 1: 20 starter + 5 monthly = 25 designs
 - Month 2: 25 + 5 = 30 total licensed
 - Month 6: 70 licensed (20 new + 30 monthly + 20 fresh starter files)
 - If you cancel or miss payment, all rights terminate immediately.

4.2. Key Rules (applicable to all Subscribers under all tiers)

- **Rotating File Policy:** Only current files remain accessible. Download files monthly to keep them if you plan to keep the subscription active.
- **No Grace Period:** Missed payment = immediate license revocation.
- **No File Redistribution:** Only physical, non-altered product sales allowed.
- **Audit Rights:** Proof of subscription may be requested.
- **No Refunds:** Early cancellation or partial use is non-refundable.
- **Rights to sell physical products** made from these files remain valid only while the subscription is active and uninterrupted. Cancellation or payment failure permanently ends resale rights for all files received. When re-subscribing, the rights to sell previous designs are NOT granted.

4.3. Upgrade & Downgrade Policy

1. Upgrading Tiers

- You may upgrade your subscription at any time via Patreon.
- Access to higher-tier benefits (e.g. additional STL files, images, consulting) begins **on the date your new tier becomes active**, based on Patreon's billing cycle.
- You will not receive **retroactive access** to files delivered in previous months under the new tier. Commercial rights in the new tier are granted only for STL files received **after the upgrade becomes active**.
- You still keep the commercial rights to all files received from the previous (lower end tier) as long as the subscription was active and paid for when upgrading.

2. Downgrading Tiers

- You may downgrade your tier at any time, but this action is considered **partial cancellation** of your previous license level.



- Upon downgrade, you immediately **lose commercial rights** to sell physical products made from STL files and use content received in higher tiers.
- Your rights are limited to content included in your **current lower-tier** only, and only while it remains active and uninterrupted.
- Files and rights from higher tiers **cannot be “carried over”** into the lower tier.
- Continued resale of designs outside your active tier is a breach of this agreement and may result in termination of your license and legal action.

3. Timing & Billing

- Patreon manages all upgrades and downgrades according to its own **monthly billing system**.
- Aquireef3D is not responsible for delays, early charges, or refunds due to Patreon’s policies.
- All license rights activate and expire **in sync with your Patreon billing status**.

4.4. License Record Verification & Responsibility

- **Issuance of Certificate.** Upon activation of a paid subscription, Aquireef3D issues to the Subscriber a **commercial-use license certificate** bearing a **unique License ID**. The certificate is personal to the Subscriber, **non-transferable** and tied to the disclosed sales channels.
- **Real-Time Verification.** Any party may verify the current status of a License ID as follows:
 - via the Aquireef3D verification page: <https://aquireef3d.com/license-verify/> (enter the License ID), or
 - by written inquiry to info@aquireef3d.com referencing the License ID.
- **Disclosure of Sales Channels (see §3).** While the license remains active, the Subscriber **must disclose all sales channels** used to sell physical products derived from Aquireef3D designs (e.g., marketplace storefronts, websites, social profiles used as shops, offline store details etc.). The disclosed channels will be displayed in the real-time license check on the Aquireef3D website.
- **Duty to Maintain Accurate Information.** The Subscriber is responsible for ensuring that their license record — **including sales channels, business name(s) and subscription status** — is accurate and up to date at all times.
- **Reporting Discrepancies.** If the Subscriber changes any sales channel(-s) or discovers any discrepancy in the license record (including but not limited to **missing/incorrect store names or outdated subscription information**), the Subscriber **must notify Aquireef3D in writing within three (3) business days of discovery** at info@aquireef3d.com.
- **Failure to notify** within this period will be deemed **tacit acceptance** of the license record and it’s listing as shown in the verification system until corrected. In case of absent timely written notice, Aquireef3D may rely on the displayed license record as accurate and complete. The verification output and underlying records may be used as **prima facie evidence** of license status and permitted sales channels.



- **Misuse & Non-Disclosure.** Operating undisclosed sales channels, providing incomplete or false information or otherwise **circumventing the verification system** constitutes a **material breach**. Aquireef3D may, at its discretion and without refund:
 - suspend or revoke the license and platform access;
 - request immediate takedown of listings;
 - pursue contractual, statutory and IP remedies, including notice to marketplaces.
- **Effect of Subscription Changes.** The verification page reflects the **current status** of the license (e.g., active / expired) incl. the expiration date. Any change in subscription status may update permitted uses and displayed sales channels; the Subscriber must cease activities that are no longer permitted.

5. INTELLECTUAL PROPERTY

All digital content provided through this subscription service—including but not limited to STL files, images, documentation, product naming and other tools / branding elements—remains the **exclusive intellectual property of Aquireef3D**. Nothing in this Agreement shall be interpreted as a transfer of ownership, joint ownership, or permanent assignment of any intellectual property rights to the Subscriber.

By subscribing to a commercial tier, the Subscriber is granted a **limited, non-exclusive, non-transferable, and revocable license** to:

- Download the STL files and image packs included in their current active subscription tier;
- 3D print and sell **physical products** based on those STL files for commercial purposes, solely while the subscription is active and uninterrupted;
- Use the included commercial image packs for marketing the licensed physical products, so long as proper credit to Aquireef3D is provided where applicable.

This license does **NOT** permit:

- Share, sell, upload, resell, trade, rent, or otherwise distribute STL files, images, or tools in any digital or physical format—modified or unmodified;
- Use any part of the files or tools for creating derivative works intended for resale or redistribution in digital format;
- Claim authorship or design credit for Aquireef3D content or any derivative based on it;
- Upload STL files to online marketplaces, file-sharing platforms, design libraries, or AI-training datasets;
- Gift, donate, loan, or otherwise transfer the files, images, or business tools to third parties in any form, even without monetary exchange. This includes giveaways, collaborations, portfolio samples, or “community sharing” and any other forms of redistribution.

All rights not expressly granted in this Agreement are **reserved by Aquireef3D**.

Violation Consequences



Any violation of these intellectual property terms will result in **immediate license termination** and may lead to:

- DMCA takedown notices
- Revocation of access to Aquireef3D content
- Public and private enforcement of copyright
- Civil or criminal legal action under applicable intellectual property laws in the EU and internationally

Aquireef3D enforces its rights actively and reserves the right to monitor subscriber activity, file takedowns, and pursue legal action in cases of infringement or unauthorized usage.

6. MONITORING & FAIR USE

- Aquireef3D encourages a transparent and fair-use environment. To support the integrity of the subscription model, **community-based reporting is accepted and encouraged**. Any **active subscriber** who reasonably suspects that a store, individual, or entity is using Aquireef3D's content in violation of this agreement—including but not limited to unauthorized sales, use of STL files without a valid subscription, improper attribution, or platform misuse—may submit a confidential report to: info@aquireef3d.com. Upon receipt of a valid report, Aquireef3D will conduct a **manual review** of the suspected sales channel.
- Online AI and manual checks are in place. Provider may use automated tools and public monitoring to verify compliance with these Terms (e.g., platform scans for STL file sharing or unauthorized sales). No private data is collected. If you believe a false flag was raised, you may appeal by contacting info@aquireef3d.com.

7. TERMINATION

7.1. Termination by the Subscriber

The Subscriber may cancel their subscription at any time by following the cancellation procedures defined by **Patreon's platform policies**. Cancellation will become effective at the end of the current billing cycle unless otherwise stated by Patreon.

7.2. Termination or Suspension by the Provider

The Provider reserves the right to **suspend or revoke** the Subscriber's license and access to all Aquireef3D content **without refund** if the Subscriber violates any term of this Policy. Grounds for termination include, but are not limited to:

- Unauthorized distribution or sharing of STL files
- Failure to disclose or update sales channels
- Breach of intellectual property rules
- Abuse of the subscription model (e.g. subscription hopping, gifting files)
- False attribution or non-compliance with crediting requirements

7.3. Effects of Termination (Voluntary or Enforced)

Upon termination for any reason:

- All rights to sell physical products based on Aquireef3D designs **are immediately revoked**.
- The Subscriber must **cease all sales activity** and remove related product listings.
- All STL files, images, and resources received under the license must be **permanently deleted** from the Subscriber's devices, cloud storage, and backup systems.
- The Provider may **request proof of takedown and deletion**, including screenshots, listing URLs, or removal confirmations.
- **Failure to comply** with post-termination obligations may result in legal action, DMCA enforcement, or platform-level takedowns.

7.4. Appeal Procedure

If the Subscriber believes the termination or suspension was issued in error, they may **submit a written appeal** with supporting evidence to info@aqireef3d.com within **7 business days** of receiving the notification. The Provider will review the case and respond in a reasonable time frame. Decisions made after appeal review are considered final.

8. LIABILITY DISCLAIMER

Aquireef3D guarantees that all designs provided through its subscription tiers are thoroughly tested, verified, and 100% printable using standard FDM 3D printers with PLA or PETG filament. Each STL design is printed and inspected in-house to ensure proper functionality and quality before distribution to subscribers.

All other content is provided "as is." Aquireef3D makes no guarantees regarding subscriber revenue, sales performance or market acceptance. The Subscriber remains solely responsible for ensuring local compliance, proper product handling and print safety.

Subscriber agrees to indemnify and hold harmless Aquireef3D from any legal claims, liabilities, or damages arising out of their use of STL files, product handling or marketing activities.

9. PRIVACY

Data is processed per our Privacy Policy. Stored for up to 12 months post-cancellation unless deletion is requested.

10. LEGAL & DISPUTE RESOLUTION

- Lithuanian (EU) law applies.
- Arbitration is default dispute method.
- Courts of Lithuania have jurisdiction if arbitration fails.



11. POLICY UPDATES

Aquireef3D may update the subscription rules, including (but not limited to) general terms, tier pricing and tier benefits. All changes will be officially published on www.aquireef3d.com and announced via the Aquireef3D Discord channel.

Each subscriber will have a 30-calendar day period to either:

- Withdraw from the subscription and give up the license;
- Switch to a different licensing plan;
- Accept the changes by continuing their subscription without further action.

In an unlikely event, if Aquireef3D plans to fully discontinue the commercial licensing program, a pre-notification period of 6 months will be observed, following the same publication and announcement protocol. During this time:

- Licensed Subscribers will be allowed to sell off any physical stock they have already printed.
- Communication and exceptions will be managed on a case-by-case basis.
- Subscribers holding a valid Lifetime License will retain all rights granted under their license indefinitely.

12. OTHER TERMS

- One user/entity per subscription.
- No API/integration access.
- All subscriptions are managed through Patreon.
- Subscriber agrees to help enforce licensing integrity.
